## 2 Ex-Greenspoon Marder Attys Launch Fla. PI Boutique

Law360, Miami (May 19, 2014, 5:10 PM ET) -- A pair of former Greenspoon Marder PA attorneys said Monday that they have branched out to start personal injury boutique firm Blaut Weiss Law Group, based in Plantation, Florida, combining their extensive experience in product defect, medical malpractice and insurance cases.
